Playground Committee: current balance \$4751.00. Will discuss some repairs needed to existing equipment in June.

Village update: Cyperski sent letter to parent of juvenile regarding damage to ball field. Working on proposal for annexation of Bunyan property at owners request and will notify Pike Township.

Jeff discussed quotes for repairs needed.
