Sheriff's report: Deputy Koehler reviewed recent activity. Activity reports were reviewed. Issues have been escalating with area youth.

Reviewed Fire & EMS reports, Dan reported over 1000 calls so far this year. Discussed fire department request for funding of retention wall. It was determined more information and planning would be needed to make a determination. With lack of room for parking on top council felt grading could accomplish acceptable result. Don will discuss further with fire department.
