

MINUTES OF THE COUNCIL OF THE VILLAGE OF EAST SPARTA, COUNTY OF STARK AND STATE OF OHIO HELD IN THE MUNICIPAL BUILDING ON May 21st2018.

The meeting was called to order at 7:00pm. Mayor Donald Stropki led Council and visitors in reciting the Pledge of Allegiance.

Roll call was taken with the following members present; Mayor Don Stropki, Joel Russell, Scott Muir, Nancy Black, Dan Fetters, Charlene Stelluto, Jackie Truax and Clerk Doug Neading. Police reports, none received, chief not responding to mayor's email regarding meeting attendance.

Reviewed Fire & EMS reports, hose testing nearly completed. Equipment will be serviced this month, Homecoming June 21-23, parade June 22nd, fireworks June 23rd.

Pool board: discussed pool water leak and filter issues.

Motion to approve repairs at cost of \$1842.80 by Stelluto. Seconded by Black. Roll call 6 yes, 0 no. Motion carried.

Motion to remove Chrissy Silvestro from park board for lack of attendance by Fetters. Seconded by Russell. Roll call 6 yes, 0 no. Motion carried.

BPA, none received.

Sharon Shoenfelt discussed overnight truck parking issue and informed council that William's has installed signage to try to eliminate problem. They do not permit overnight truck parking at their location. Informed council of junk car without plates at 2185 Pine and would like to see it

removed. Informed council that Hilton property has went back to the bank and is vacant.

Glen McDade asked that people were made to mow grass and maintain properties. Mayor Stopki inform residence they continue to work on stronger ordinance for zoning inspector to enforce.

Rob Qicci reported storm drain on Cedar is plugged, asked about culvert replacement and requested update playground equipment for village park.

Motion to approve April 16th2018 minutes by Stelluto. Seconded by Fetters. Roll call 6 yes, 0 no Motion Carried.

Motion to approve financial reports as presented by Truax. Seconded by Russell. Roll call 6 yes, 0 no. Motion Carried.

Accepted paving bid from Milhaon Asphalt Maintenance. Work divided into 2 phases summer and fall. Motion to approve phase 1 \$59,440.00 by Stelluto. Seconded by Truax. Roll call 6 yes, 0 no. Motion carried.

Cemetery paving project was tabled.

Discussed tree removal @ Westbrook and Main. It was decided to wait on information from Army Corp. Village is #2 on funding priority list.

Motion to approve banner and bracket replacement at cost of \$5722.00 by Stelluto. Seconded by Black. Roll call 6 yes, 0 no. Motion carried.

Motion to approve catch basin repairs at cost of \$2730.00 by Russell. Seconded by Muir. Roll call 6 yes, 0 no. Motion carried.

Motion to approve street sweeping at cost of \$1200.00 by Fetters. Seconded by Black. Roll call 6 yes, 0 no. Motion carried.

Motion to reject Bell Construction solicitation permit request by Stelluto. Seconded by Fetters. Roll call 6 yes, 0 no. Motion carried.

Legal update: Cyperski presented zoning variance request from Marathon for Maple property. Hearing date will be set. Discussed needed changes in property maintenance ordinance. Bob will present updated ordinance to council in June.

Village update: Jeff reported that round a bout will be closed for about 3 days for concrete repairs.

Discussed request to name and label alleys for emergency responders.

Motion to adjourn by Fetters. Seconded by Muir. Roll call 6 yes, 0 no. Meeting adjourned 8:38pm.
