

**MINUTES OF THE BOPA OF THE VILLAGE OF EAST
SPARTA, COUNTY OF STARK AND STATE OF OHIO HELD
AT THE NEUMAN FACILITY January 10th 2023.**

The meeting was called to order at 7:00pm.

Motion to appoint Balash as president by Hoover. Seconded by Parker. Roll call 3 yes, 0 no Motion carried.

Motion to have repairs made to F250 differential seal at cost estimate of \$300.00 at Sarchoine Ford by Hoover. Seconded by Render. Roll call 3 yes, 0 no. Motion carried.

Need to add Don Feller to “TONKA” call out system.

Need to provide access to Sheriff’s deputy assigned to East Sparta.

Mike and Tom will work on EPA equipment grant application.

Don Feller will contact EPA for existing lead pipe mapping information and update report.

Water meter was removed from S. Chestnut property that is scheduled for demolition.

Will work with fire department on disposal of existing brush piles.

Water leak on customer side will be repaired Saturday at Chestnut and Ash. BPA will not charge customer for turning water on/off.

Work on cleaning up stockpile area and have asphalt grinding put there this summer to build up a base.

Doug will call software provider to update phone number on water billing.

Don Feller recommended purchasing iron and manganese testing kits for use at plant instead of sending out samples for evaluation. He will get cost.

Don Feller has begun to slightly adjust chlorine levels down a little. Marathon has repaired water line break on their property 12/27/22. Water line has been restored at village hall.

Motion by Balash to adjourn. Seconded by Hoover. Roll call 3 yes, 0 no. Motion carried.
