## MINUTES OF THE COUNCIL OF THE VILLAGE OF EAST SPARTA, COUNTY OF STARK AND STATE OF OHIO HELD IN THE COMMUNITY BUILDING ON October 18<sup>th</sup> 2022

The meeting was called to order at 7:00pm. Mayor Stropki led Council and visitors in reciting the Pledge of Allegiance.

Police reports. Officer Schlimm review reports. Chief Hager provided update on recent dog issue. Continue to notify Magnolia PD and Stark County Dog Warden of any future incidents. Also informed council that video of traffic concerns on Walnut did not provide plate numbers and he was unable to determine parties involved.

Reviewed Fire & EMS reports, Dan invited council to Holiday party at firehouse, they are bidding online for a used tanker to update unit.

Pool board: reviewed meeting minutes. Cyperski sent letter to refund pavilion letter, party stated they were not involved in complaint; he requested additional information from park board and will follow up. Linda does have a person interested in being pool manager for next year. Pool board asked council to consider a levy to support parks and recreation, consider converting to salt water in place of chlorine, need to get estimates on electrical upgrades that are needed. Picnic tables need repaired.

BPA report: reviewed minutes. Cyperski expressed concerns over visitors entering into plant and the practice of loaning BPA equipment. BPA needs to maintain facility security and limit to employees only. Suggested the same practice for all village property. Cyperski will

prepare an ordinance to address at Water Treatment Plant and Municipal Building.

Cindi Edwards asked about barking dogs, Police Dept. would need to follow existing noise ordinance if receiving complaints.
